Reviewed and discussed FY22 Uses of Funds Total Net Income is expected to finish around \$7.9M. This is ahead of budget for the year and primarily the result of HEERF related activity in FY22. Standard operating cash is anticipated to end the year at \$8.7M. This is ahead of budget by \$1.0M due to pandemic funding. The increase in October cash is due to changes in State funding for Excel in CTE. The Operating Cash Reserve is expected to be fully funded at the 6 Month operating target balance of \$14.5M. We did this in half the time we expected. Reminder the college will be setting up an innovation fund for \$1M.
